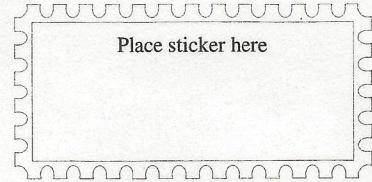

*All terms described are guaranteed in this agreement. There are NO REFUNDS on rents paid. Rental fees are due in advance. Instrument rental is by the month and rents are due on the 1st of every month, no invoices will be sent. If rent fees are over 10 days late, a \$5.00 per month late fee will apply. Renter must notify Arizona Music Pro of any address, phone number, credit card or employment changes. Renter may return the rented instrument at any time to Arizona Music Pro and this agreement will terminate provided all rental fees are paid current at the time of safe return. DO NOT RETURN THE INSTRUMENT TO THE SCHOOL. Renter will be fully responsible for the instrument and its safe return to Arizona Music Pro (AMP).

*MAINTENANCE / THEFT COVERAGE ___ YES ___ NO INITIAL _____
 Covers all parts and repair costs associated with normal maintenance or adjustments. Does not cover misuse or improper care of instrument, reeds or strings. Repairs for misuse or improper care of instrument will be paid for by Renter. In the case of theft, renter must report the incident within 48 hours to law enforcement authorities and provide a copy of the bona fide police report (with valid report number) to AMP within (15) fifteen days of incident. Police report must include brand and serial number of stolen instrument with Arizona Music Pro listed as owner of stolen rental property. There is NO coverage in the case of "Careless Misplacement" or "loss" of instrument. Renter will be responsible to AMP for the replacement value of the instrument rented. Instrument coverage is void if a rental account is over 10 days late.

*If this account becomes more than 10 days past due or the instrument is returned with a balance owed on the account, RENTER authorizes Arizona Music Pro to charge to the RENTER'S credit card account listed on rental agreement the total balance of rent and late charges due. If this account becomes more than 45 days past due it will be considered in default and may be turned in for collections and/or repossession. AMP shall be entitled to all late fees, collection fees, attorney fees and repossession fees. In addition, AMP may construe it as an unlawful failure to return rented property and may prosecute under Arizona Revised Statutes #13-1802 and/or ARS #13-1806.

*Purchase Credit: At any time during the term of this Rental Agreement or at the end of said term, and provided that Renter has timely fulfilled all obligations to AMP under this agreement, Renter will receive credit toward a "Qualified Purchase" as hereinafter defined equal to the total rental fees paid on time hereunder, less amounts for sales tax and insurance. Credits will not apply to the rentals of Guitars, Drums, Bells or Keyboards.

A Qualified Purchase is defined as follows:
 Purchase of a new instrument of the same type rented of equal or greater value, as determined by AMP. Instrument selection will be a choice by renter from AMP's product line inventory, with selling price to be determined by the current manufacturer's suggested retail price. CREDITS ARE NOT TRANSFERABLE. Credits from more than one rental agreement may not be combined to a single purchase. Credits may not be applied towards Layaways this credit towards a Qualified Purchase does not give the Renter an ownership interest in the instrument rented, but rather is a separate contractual right granted by AMP, and must be exercised strictly according to the terms of this agreement. In the event of default by renter in fulfilling the terms of this Agreement, this right automatically terminates.

*The information set forth above is true and correct. I authorize Arizona Music Pro to obtain whatever credit information they determine to be necessary, including the running of a credit report and verification of employment if necessary. I have read this agreement in its entirety and agree to be bound by its terms & conditions.
